Outpatient Bills with Unlisted J-Codes

Quick Reference Guide

Previously, payment for outpatient bills (UB-04) with unlisted J-Codes was determined through OPPS or OWCP fee schedule. Effective 5/28/2022, outpatient bills, with 13X or 14X type of bill, submitted with an unlisted J-code, will go through OPPS for pricing. If the unlisted J-code is not considered a bundled service, the service line will be sent to the PBM vendor (Optum for DFEC and Conduent for DEEOIC) for pricing. This change is only applicable for the DFEC and DEEOIC program.

- The following unlisted J-Codes are approved by DOL:
 - o J3490
 - o J3590
 - o J7999
 - o J8499
 - o J8999
 - o **J9999**
- National Drug Code (NDC) will be required for all outpatient bills with unlisted J-codes. The NDC can be found in box 43 on the UB-04 form.
- All unlisted J-codes must be submitted with Revenue Center Code (RCC) 0636.
- Providers will receive an error message if the NDC is not provided during direct data entry.
- Bills will be denied if:
 - Invalid NDC is used
 - NDC is part of denied NDC list
 - Unlisted J-code submitted with an RCC other than 0636
- Bills sent to PBM will be priced within 1-3 business days.
- Bills sent to PBM for pricing may be unable to be priced for additional reasons such as no drug pricing on file for date of service (edit 61522) or discontinued NDC number (edit 61689).
 - Error code details should be verified to determine denial reason in WCMBP system.
