



Federal Employees Compensation Act (FECA) Program



Enroll as an OWCP Provider

Help OWCP serve injured workers who suffered work-related injuries and illnesses.

- Claimants may use the doctor of their choosing, including their primary care physician. Once you enroll and begin submitting bills, **claimants can find you through our provider search** feature on the web portal.
- Once registered, electronic **payment is seamless**. We process and submit payment for 96% of bills within 15 days, 98% of bills in 28 days.
- **OWCP pays better than Medicare**, typically 56% higher. The fee schedule is published online at: **<https://www.dol.gov/agencies/owcp/regs/feeschedule/accept>**.
- 92% of prior authorizations are processed within 3 days.
- We pay medical benefits for approximately 155,000 claimants annually.
- You can submit bills electronically via Electronic Data Interchange (EDI) and online through the web portal. A paper option is also available.

- The **FECA program is a non-adversarial program**. Physicians provide care that the claimant/patient needs and periodically provide a written statement supporting the treatment.
- Medical providers who treat injured federal workers are under no obligation to perform formal long term disability evaluations for the injured worker. (Although they have the option to do so.)

- Once registered, electronic **payment is seamless**. We process more than half of all bills within 15 days, 80% of bills in 28 days.
- **OWCP pays better than Medicare**, typically 56% higher. The fee schedule is published online at: **www.dol.gov/agencies/owcp/regs/feeschedule/fee**.
- You can **submit bills electronically** via Electronic Data Interchange (EDI) and online through the web portal. A paper option is also available.

- Most **accepted claims provide permanent medical benefits** for claimants to treat approved conditions. Treatments for the conditions are covered without extensive reassessments from the physician.





Federal Black Lung Program



Enroll as an OWCP Provider

Help OWCP serve coal miners covered by the Black Lung Disability Trust Fund, who are totally disabled by black lung disease.

- The Federal Black Lung Program understands the **importance of developing and maintaining solid relationships with healthcare providers**, as well as the barriers that miners face in accessing healthcare services for covered conditions. We're committed to supporting healthcare providers in providing quality care and services. As an enrolled provider, you can access eligibility, claim status, and authorizations information online.



- Once registered, electronic payment is seamless. We process 95% of bills in 15 days, and 98% of bills in 28 days.
- **OWCP pays better than Medicare**, typically 47% higher. The fee schedule is published online at: <https://www.dol.gov/agencies/owcp/regs/feeschedule/fee>.



- Easy to enroll online via the **web portal** at <https://owcpmed.dol.gov/>. Just fill out a basic application to show you are licensed to provide care in the state you work in.
- Online submissions are the fastest and easiest way to submit a bill. You can **submit bills electronically** via Electronic Data Interchange (EDI), online with the web portal, or by paper. You can also upload medical notes or attachments.
- The Federal Black Lung Program utilizes the Certificate of Medical Necessity (CMN) for prior authorization requests.
