## **1 INTRODUCTION**

The Workers' Compensation Medical Bill Process (WCMBP) Provider Manual offers medical providers an easy way to access information regarding enrollment, authorizations, billing processes, outreach, call center, important forms, and procedures associated with the WCMBP System.

We are pleased you have chosen to participate in our mission to protect the interests of workers who are injured or become ill on the job, their families, and their employers by making timely, appropriate, and accurate decisions on bills, providing prompt payment of benefits, and helping injured or ill workers return to gainful work as early as is feasible.

The Office of Workers' Compensation Programs (OWCP) contracted Acentra Health to manage the WCMBP System and provide services such as provider enrollment, bill processing, authorizations, and call center assistance for our providers and injured or ill workers.



## 2 THE OFFICE OF WORKERS' COMPENSATION PROGRAMS OVERVIEW

Welcome to the United States Department of Labor Office of Workers' Compensation Programs (US DOL OWCP). OWCP administers three major disability compensation programs. OWCP's programs provides wage replacement benefits, medical treatment, vocational rehabilitation, or other benefits to eligible workers or their dependents who experience work-related injury or occupational disease.

## 2.1 The Division of Federal Employees' Compensation Program

The Division of Federal Employees' Compensation (DFEC) administers the Federal Employees' Compensation Act (FECA) to adjudicate new claims for benefits from federal workers and manages ongoing cases; pay medical expenses and compensation benefits to injured or ill workers and survivors; and help injured employees return to work when they are medically able to do so.

A two-page document that provides information that may be helpful to providers, including information on enrollment, verifying claimant eligibility, the authorization process, billing OWCP, helpful online portal tools, and call center information.

## 2.2 The Division of Energy Employees Occupational Illness Compensation Program

The mission of the Division of Energy Employees Occupational Illness Compensation (DEEOIC) Program is to deliver benefits to eligible employees and former employees of the Department of Energy, its contractors, and subcontractors or to certain survivors of such individuals, as provided in the Energy Employees Occupational Illness Compensation Program Act. The mission also includes delivering benefits to certain beneficiaries of *Section 5 of the Radiation Exposure Compensation Act*.

## 2.3 The Division of Coal Mine Workers' Compensation Program

The Division of Coal Mine Workers' Compensation (DCMWC), or Federal Black Lung Program, administers claims filed under the Black Lung Benefits Act. This Act provides compensation to coal miners who are totally disabled by pneumoconiosis arising out of coal mine employment, and to survivors of coal miners whose deaths are attributable to the disease. This Act also provides eligible miners with medical coverage for the treatment of lung diseases related to pneumoconiosis.

## **3 WCMBP SELF-SERVICE PORTAL**

Acentra Health hosts the OWCP Medical Bill Processing Portal with self-service features for providers, claimants, claimant representatives, DOL Staff, and Acentra Health employees. Providers have access to news, helpful resources, and other publicly available information on the portal pages. Through a secure online self-service portal, registered users have fast and direct access to billing, claimant eligibility, authorization, and provider enrollment features.

To access the WCMBP self-service portal, providers must register through OWCP Connect. Providers can refer to the <u>Provider Registration for Online Access Quick Reference Guide</u> to create an online account. OWCP uses an identity-proofing system to create and authenticate credentials for users that log in to the provider WCMBP self-service portal account. Account registration is a one-time requirement for all providers who utilize the WCMBP self-service portal features, which include:-

## 4 PROVIDER ENROLLMENT OVERVIEW

Qualified Medical and Non-Medical providers must enroll in an OWCP program to be paid for treating an OWCP injured or ill worker. Enrollment is free of charge.

Providers are encouraged to enroll in one or more of the three OWCP Programs.

Enrollment with OWCP *is not* a Preferred Provider Organization (PPO) enrollment. To enroll, providers must complete and submit a Provider Enrollment Application (OWCP-1168), which includes a completed Automated Clearinghouse (ACH) form for OWCP to make electronic payments.

## 4.1 Enrolling as a New Provider

Billing Agents and Clearinghouses must complete the Electronic Data Interchange (EDI) enrollment template located on the WCMBP self-service portal.

Providers can submit completed applications through the WCMBP self-service portal, by mail, or by fax. All submitted applications must be fully completed. Paper and faxed applications must be accompanied by a completed and signed ACH form. Paper and faxed applications must be submitted with a "wet" or hand-written signature, while applications submitted via the WCMBP self-service portal can be submitted with an electronic signature.

### 4.1.1 Automated Clearinghouse Form

The Automated Clearinghouse (ACH) form collects the provider's banking information so OWCP can make payments for services, required under the provision of 31 U.S.C. 3322 and 31 CFR 210. This information is used by the Department of Treasury to transmit payment data by electronic means to the provider's financial institution. Failure to provide the requested information may delay or prevent the receipt of payments through the Automated Clearinghouse Payment System.

For applications submitted using the online portal, banking information is collected directly on the secure web portal. For paper or faxed applications, the ACH form must be completed, signed, and submitted with *a "wet" or hand-written signature.* 



Once the application is submitted and ACH data is verified, the enrollment process is completed within seven business days.

## 4.2 Submitting an Enrollment Application Online through the Portal

Using the online enrollment application method ensures providers receive real-time validation to confirm the user is completing all required fields and actions. Once a provider submits an application, the information goes directly to the Provider Enrollment Unit allowing for faster review and approval.

To enroll online, providers must register through OWCP Connect. This registration process is a centralized identity-proofing system used to create and authenticate credentials for a user when logging into the provider WCMBP self-service portal. Account registration is a one-time requirement for all providers who are utilizing the WCMBP self-service portal features.

Providers receive an email to the email address entered during the registration process advising that an OWCP Connect online access account is now created. A link is provided to activate the account. Registration is a one-time activity.

Once the provider activates the OWCP Connect account, they can complete the enrollment application, electronically sign, and submit the enrollment application online. The provider can upload all necessary attachments such as a copy of a license or certification with the application.

To begin the OWCP Connect portal registration and enrollment process, providers can refer to the <u>Provider Registration for Online Access Quick Reference Guide</u> to create an online account.

After beginning the enrollment process, providers will receive an application number to uniquely identify their online provider enrollment application. Providers who initiate but do not submit their enrollment application may recall the application by logging in to OWCP Connect through the Resume or Track an Enrollment Application option. Providers can recall the application by entering the application number and tax ID associated with the enrollment application. If the application number is not known or available, providers may locate the application using a National Provider Identifier (NPI) and tax ID. ## 4.3 Submitting an Enrollment Application by Mail or Fax

Providers can submit a completed enrollment application through mail or fax.



### 4.3.1 Submitting a Paper Enrollment Application by Mail

Providers can submit a paper submission for enrollment purposes. Obtain an OWCP-1168 form from the <u>Office of Workers' Compensation Programs General Administrative Forms &</u> <u>References (dol.gov)</u>. Mail completed and signed paper applications to the following address:

### 4.3.2 Submitting an Enrollment Application by Fax

Providers may also fax completed enrollment applications to 1-888-444-5335. Obtain an OWCP-1168 form from the <u>Office of Workers' Compensation Programs General Administrative</u> Forms & References (dol.gov). All faxed enrollment applications with supporting documentation must be submitted with a Provider Enrollment Supporting Documents Cover Sheet. Obtain a PDF <u>Provider Enrollment Cover Sheet</u> from the WCMBP self-service portal. This PDF requires Adobe Reader.

Once the Provider Enrollment Unit receives, reviews, and approves the enrollment application, they send a system-generated hard copy welcome letter to the provider that includes a 9-digit OWCP provider ID. This OWCP provider ID is required to complete the registration process with OWCP Connect to access online features of the self-service portal.

## 4.4 Provider Enrollment Types

The Department of Labor (DOL) accepts four enrollment types as indicated on the Provider Enrollment Application (OWCP-1168). Provider enrollment types are listed and defined in <u>Section 4.4.1 Individual Providers</u> through <u>Section 4.4.4 Billing Agents and Clearinghouses</u>.

### 4.4.1 Individual Providers

Enrollment as an individual provider is defined as follows:



- Any provider who is eligible to receive a Type I National Provider Identifier (NPI) through the National Plan and Provider Enumeration System (NPPES); providers eligible to receive an NPI are those who deliver medical or health services, as defined under Section 1861(s) of the Social Security Act, 42 U.S.C. 1395x(s).
- Individuals providing only non-medical services, attendant care, or personal care services do not need an NPI to enroll.

### 4.4.2 Group Providers

Enrollment as a group provider is defined as follows:

- One or more healthcare practitioners who practice their profession at a common location (whether they share common facilities, common supporting staff, or common equipment) and have formed a partnership or corporation or are employees of a person, partnership, or corporation, or other entity owning or operating the health care facilities at which they practice.
- These entities have a Type II NPI from the National Plan and Provider Enumeration System (NPPES).

### 4.4.3 Facilities

Enrollment as a facility is defined as follows:

- An Inpatient or Outpatient Hospital, a Skilled Nursing Facility, an Intermediate Care Facility, a Clinic (RHC, FQHC, Hospital-Based Clinic, Urgent Care), a Psychiatric Facility, a Mental Institution, a Durable Medical Equipment Supplier, a Free Standing Ambulatory Surgical Center, a Long Term Care Facility, an Independent Clinical Laboratory, a Free Standing Radiology Clinic or Center, a Dialysis Center, a Partnership, a Corporation, or any other entity that furnishes or arranges for the furnishing of services for which payment is billed under the OWCP programs
- It does not include individual practitioners or groups of practitioners; additionally, they must also be eligible to receive and currently possess a Type II National Provider



Identifier, available through the National Plan and Provider Enumeration System (NPPES).

Any entity, other than an individual, that does not deliver medical care or health services is ineligible for an NPI, which is available through the NPPES. This provider type can include Fiscal Intermediaries, Non-Emergency Transportation, and other entities.

### 4.4.4 Billing Agents and Clearinghouses

Providers may submit bills themselves or choose to utilize a billing agent. Enrollment as a billing agent or clearinghouse is defined as follows:

- Offers claims submission services to Providers.
- Submits bills electronically via Electronic Data Interchange (EDI).
- Completes an EDI Enrollment Template for Billing Agent or Clearinghouse and not the OWCP-1168 form.

OWCP does not require business agreements to allow Trading Partners to submit bills on behalf of an OWCP provider. Enrolling as a billing agent or clearinghouse allows the Trading Partner to receive a unique OWCP ID. Trading Partners may enroll with OWCP using the WCMBP Portal or by submitting the EDI Enrollment Template via mail or fax.

## 4.5 Existing Providers and Enrollment Status

Existing providers are those who have enrolled with OWCP and have received a 9-digit OWCP provider ID. A provider's enrollment status is listed as either active or terminated on their provider file in the WCMBP System.

### 4.5.1 Active Providers

A provider is considered "active" when all the following applies:

- An active medical or non-medical license or certification is on file in the WCMBP System.
- Provider passes the IRS validation.



- Completed W9
- Business name cross match to IRS
- The Provider Enrollment Unit verifies banking information received from the provider.
- Provider is assigned an OWCP 9-digit provider ID number.

All active providers can use the WCMBP self-service portal to manage and modify their provider information, upload license or certifications, check eligibility, and submit bills and authorization requests.

Other portal capabilities include:

- Adding or Associating Users to Providers
- <u>Reset Password Guide for Providers</u>
- Opting out of the Provider Search Function
- Adding Servicing Providers

#### 4.5.2 Terminated Providers

A provider is considered "terminated" for any of the following reasons:

Medical or non-medical license or certification has expired.

**Note:** A terminated provider may re-activate their provider file by updating or modifying their license or certification information.

• The provider is "excluded."

DOL can reinstate an excluded provider. In these instances, DOL sends notification of the reinstatement to the Acentra Health Provider Enrollment Unit. The provider must complete the OWCP-1168 form as a new enrollment. Once the application is received and all information is verified, the provider receives a new OWCP 9-digit provider ID number.

## 4.6 Credentialing and Re-Credentialing

The credentialing and re-credentialing process validates the professional competency and conduct of enrolled providers. This includes verifying licensure and board certifications, as well as identifying adverse actions, including billing malpractices.



## 4.6.1 Credentialing

Providers must include the following information when submitting an enrollment application:

- Completed, signed, and dated provider enrollment application.
- Completed disclosure statement on the OWCP-1168
- Copy of current unrestricted active and valid state-issued medical, nursing, or similar licenses and certifications

### 4.6.2 Re-Credentialing and Modifications

The OWCP WCMBP System requires license and certification expiration dates for individual providers, servicing providers within a group practice, and facilities. The provider receives 60-day and 30-day reminders when licenses are nearing expiration. A final notice of termination letter is issued if no actions are taken to update the provider information prior to the license expiration date.

A provider whose license expired will show a status of "terminated – license expired" in the WCMBP System.

Until action is taken to update the license information, providers appearing in a "terminated – license expired" status are not eligible to receive payment for rendered services. Services *may be eligible for payment if the service date is prior to the license expiration date.* 

Providers can use the WCMBP provider self-service portal to update licensing information and submit supporting license documentation. Services *may be eligible for payment if the license information is submitted, and the provider status is reinstated as "active" after the license is verified.*

## **5 MEDICAL AND NON-MEDICAL PRIOR AUTHORIZATIONS**

Prior authorization is a process by which a provider must obtain approval from OWCP before rendering a particular treatment or procedure. DFEC and DEEOIC Authorization templates and forms are available for services such as Durable Medical Equipment (DME), General Medical, Physical Therapy or Occupational Therapy, Surgical, Home Health, and others. If prior authorization is required but is not obtained, the submitted bill is denied even if the procedure is medically necessary and would otherwise have been covered. However, providers may obtain authorization retroactively. Payments will be processed after the retroactive authorization request is received and approved.

Prior authorization can be submitted on the following templates or forms, as appropriate:

#### For DFEC:

Providers must use the CM-893 (Certification of Medical Necessity) for authorization requests. The CM-893 form is specifically for Durable Medical Equipment (DME), Oxygen supplies, and Home Nursing Services. The treating physician must sign and date the form. The CM-893 form can be submitted electronically or by mail.

## 5.1 Authorization Submissions

Some procedures require pre-authorization before being reimbursed for payment. Providers who render services to injured or ill workers related to the workers' accepted conditions may submit authorization requests. Completed authorization requests can be submitted either online via the WCMBP self-service portal using Direct Data Entry (DDE), by paper, or via fax.

### 5.1.1 Online Submission

Providers are encouraged to submit authorization requests through the WCMBP self-service portal using DDE. Utilizing this method of submission will notify the provider immediately if authorization is or is not required. Submitting online through the WCMBP self-service portal also ensures the request is immediately routed to the appropriate approver. Providers must be actively enrolled in the program for which they are submitting an authorization request.

### 5.1.2 Fax Submission

Providers must read the form instructions carefully when completing prior authorization requests. All applicable fields must be complete.

When submitting authorization requests via fax, it could take up to 24 hours for the fax to be ingested into the WCMBP System.

If a provider uses the incorrect template or form, the request is faxed back to the fax number from which it was submitted. The faxback will inform the provider that an incorrect authorization request template was submitted and to please submit the correct authorization request template or form as it relates to the service being rendered. In addition, a letter is mailed to the provider listed on the authorization template or form advising the provider to resubmit the authorization request using the correct authorization template or form.

If a faxed authorization request is submitted on a correct template or form, with all required information, Acentra Health will enter all faxed authorization requests received into the WCMBP System. If the authorization request has missing or invalid mandatory information, the faxed request is returned to the provider via USPS mail for correction. Providers are encouraged to submit authorization requests through the WCMBP self-service portal which will allow providers to receive real time responses and make real time corrections if needed.

### 5.1.3 Mail Submission

When submitting authorization requests via mail, it can take up to 24 hours for the request to be received and entered in the WCMBP System once it is received in the mailroom. All paper submissions must use the correct form or template for the information to be added to the WCMBP System. If the correct form is not received, the submitter receives a Return to Provider (RTP) letter, indicating that the authorization was submitted on the incorrect form or template and must be resubmitted.

## **5.2 Authorization Determinations**

The responsible Claims Examiner (CE) or Medical Benefits Examiner (MBE) reviews authorizations. Based on the information provided on the authorization template or form, and any supporting documentation, the CE or MBE can make one of the following determinations.

**Approve:** An Approval letter is sent to the provider. The letter includes:

Claimant Name and Case Number

- All Approved Procedures, CPT HCPCS
- Approved Date of Service (DOS) and Units or Dollar Amount
- Authorization Identification Number

**Approve or Deny:** Certain services on the authorization template or form have been approved while other requested services may have been denied.

- A letter is issued to the claimant for the denied codes.
- A letter is issued to the provider (for the approved codes only)
- A letter for denied codes is issued to the provider (DEEOIC and DCMWC providers only)

Denied: The CE or MBE has denied the authorization request.

The CE or MBE issues a Denial letter to the claimant, which includes the reason for the denial and requests any additional information needed for further consideration.

**Pending Further Development:** The CE or MBE has pended the authorization request to obtain additional information needed for a final determination.

- Acentra Health issues a generic letter to the provider indicating the authorization request cannot be approved, and that OWCP will contact the claimant with further details.
- The CE sends a letter to the claimant or provider advising them of the information necessary to further consider the authorization request.

## 5.3 Correcting an Approved Authorization Request

DFEC and DEEOIC providers can request a correction of approved services to extend the dates of service, increase the approved units or amount, or add a new service code. Corrections can be submitted online through the portal, by fax, or by mail. The WCMBP self-service portal auto-populates all the required information from the original authorization for the submitter to make



corrections. This is the fastest method to request a correction to an authorization. If a correction authorization request is approved, then the original authorization is updated to reflect the approved changes, and the correction authorization request will appear in a "Corrected" status.

The DFEC program allows corrections for all authorization templates outlined in <u>Section 5</u> <u>Medical and Non-Medical Prior Authorizations</u>.

The DEEOIC program only allows corrections for the following authorization types:

- Rehabilitative Therapies
- Home Health Care

## 5.4 Canceling an Authorization Request

DFEC and DEEOIC providers can cancel an authorization request when an error has been identified. The "Cancel Authorization" button is a feature available to the DEEOIC and DFEC programs that allows providers to cancel submitted authorizations that are still in the "In-Review" or "Processed Awaiting Decision" status. Once the authorization is canceled, all services requested under the authorization request will be canceled.



## 6 BILL PROCESSING

Providers, including billing agents and clearinghouses, can submit bills for services rendered to an OWCP injured or ill worker through the following methods:

- Direct Data Entry (DDE) through the WCMBP self-service portal
  - Bills can be data-entered and attachments uploaded to the WCMBP System in realtime.
  - For more information on this submission method, refer to <u>Section 6.1 Direct Data</u> <u>Entry</u>
- Electronic Data Interchange (EDI) through the WCMBP self-service portal
  - EDI bills can be submitted as batch only.
  - EDI bills can be submitted with attachments through a secure file transfer protocol (SFTP) folder.

*If a provider has not yet enrolled, and submits a bill,* the bill will be returned along with a Return to Provider (RTP) letter, directing the provider to the WCMBP self-service portal to obtain an enrollment packet. Once the provider completes the enrollment and their OWCP provider ID is active, they may resubmit the returned bill or bills with the assigned active provider ID for



processing of payment. Refer to <u>Section 4 Provider Enrollment</u> for information on the enrollment process.

Effective August 24, 2024, providers are required to submit billing National Provider Identifier (NPI) when billing for services provided to injured or ill workers for the Office of Workers' Compensation Programs (OWCP). Professional and institutional bills submitted without the billing NPI after August 24, 2024, will be rejected or denied. Billing NPI is not required for OWCP bills submitted from providers such as non-medical vendors, fiscal intermediaries, and non-emergency transportation.

## 6.1 Direct Data Entry

Providers can have bills processed more effectively and efficiently by submitting bills via Direct Data Entry (DDE). Providers can enter a bill directly into the WCMBP System where upfront editing will occur with instant notification of errors prior to submission.

Other benefits include:

- Ability to immediately make corrections to bills posting errors.
- Provider bills and attachments upload to the WCMBP System in real-time.
- Eliminates provider expense for paper, printing, storage, and postage.
- Eliminates the potential for lost mail.

When submitting online through the WCMBP self-service portal, the provider must have a registered account through OWCP Connect.

## 6.2 Electronic Data Interchange

Electronic Data Interchange (EDI) X12, is a data format based on the Accredited Standards Committee (ASC) X12 standards. EDI allows one company to send information to another company electronically, rather than using paper. Business entities conducting business electronically are known as "Trading Partners." A Trading Partner may represent an organization, group of organizations, or any other business entity.

A Trading Partner enrolls with OWCP as a Billing Agent or Clearinghouse. For further information, refer to Section <u>4.4.4 Billing Agents and Clearinghouses.</u>



EDI bills can be submitted through a Health Insurance Portability and Accountability Act of 1996 (HIPAA) Batch or through a Secure File Transfer Protocol (SFTP) Batch. While both methods are accepted into the WCMBP System, there are some differences, which are listed in <u>Table 4</u>.

The WCMBP System processes the following EDI transaction and acknowledgement files:

- 837 Inbound File: An electronic file that contains information about patient claims that are sent by healthcare providers to a payor (OWCP); for more information on electronic submission of 837 Claims Transactions to the WCMBP System, refer to the <u>837</u> Companion Guide.
- 835 Outbound File: Is the electronic Remittance Voucher (RV) or Explanation of Benefits (EOB) sent by the payor (OWCP) to the providers about the healthcare services being paid or denied; for more information about the 835 healthcare payment, refer to the <u>835 Healthcare Claim Companion Guide.</u>
- TA1 Outbound Acknowledgement: Reports the status of processing an interchange; this report confirms whether EDI successfully received the interchange or transmission, and it notifies the Trading Partner of any encountered errors after it verifies the envelope structure.
- **999 Outbound Acknowledgement:** A response that a file was received properly.

## 6.3 Paper Bill Submission

Providers can submit paper bills. Providers print the OWCP-1500 or OWCP-04 bill form, fill out completely, sign, date, and mail form to one of the following applicable addresses:

DFEC and DEEOIC providers can also print and submit the ADA Dental Claim Form.

Bills received in the mailroom are keyed into the WCMBP System for review and are processed for payment consideration. If information is missing or invalid on the submitted bill, the mailroom returns the bill to the provider listing the Return to Provider (RTP) reason. Processing time for submitted bills is 28 calendar days from the date received in the mailroom.

## 6.4 Bill Templates

The WCMBP System features bill templates that allow providers to create preset formats for billing OWCP, reducing the need to recreate an entire bill with each submission. By using the bill template in the WCMBP provider self-service portal, providers can submit a bill in real time.

Only providers who are registered on the WCMBP provider self-service portal can access the bill templates.

## 6.5 Adjustments vs Appeals

This section explains the difference between an adjustment versus an appeal of a previously paid or denied bill submitted by the provider. Understanding the differences will help to reduce confusion and repeated denials.



### 6.5.1 Adjustments

Adjustments are requests for the reprocessing of a bill due to a correction or a changed aspect of a previously submitted bill which was partially paid or denied.

Adjustments can be submitted for reasons such as billing errors, incorrect charges, or eligibility updates.

#### Examples:

- The procedure code was incorrectly keyed into the system causing the bill line to deny in error.
- The bill processed and paid as submitted; the provider identifies that wrong charges were submitted on one of the bill lines and initiates an adjustment to correct the error.
- The bill was processed and denied due to the claimant not being eligible for the dates of service.

Adjustments may be submitted for previously paid or partially paid bills using the WCMBP Portal for DFEC, DEEOIC, and DCMWC claimants.

When submitting an adjusted bill by paper, providers must complete the "Adjustment Request" template and attach it to the adjusted bill.

- DFEC: The adjustment template is mandatory and if not submitted with the adjusted bill, the request will be Returned to the Provider (RTP) instructing the provider to utilize the adjustment request template.
- **DEEOIC:** The program does not mandate the adjustment template for bill adjustment requests; providers can simply submit their adjusted bill.
- DCMWC: The program does not mandate the adjustment template for bill adjustment requests; providers can submit a request for adjustment processing in writing directly to the DCMWC WCMBP representative.

### 6.5.1.1 How to Submit an Adjustment Request

An adjustment request can be submitted using DDE through the WCMBP provider self-service portal or by paper, mailing the request to the Acentra Health mailroom.

For faster processing, Acentra Health recommends submitting the adjustment request through the portal.

#### Direct Data Entry (DDE):

- Providers can use the "Bill Adjustment" feature on the WCMBP provider self-service portal.
- Providers can make corrections and submit additional documentation that upload directly into the WCMBP System.



- After the adjustment is submitted, providers receive a confirmation stating the bill adjustment request was submitted successfully.
- An adjustment template is not required when submitting an adjustment via DDE.

#### Paper Submission (Mail):

- Providers make corrections to the previously submitted bill, which was partially paid or denied.
- Download the Adjustment Template, which is mandatory for DFEC.
- Complete all five fields on the Adjustment Template and select the reason and explanation for the adjustment.
- Providers must sign and date the Adjustment Template.
- Providers must place the Adjustment Template as the first page with all supporting documentation following behind.
- Providers mail the Adjustment Template and supporting documentation to the applicable address:

Providers are not able to void bills in the WCMBP System.

Providers who wish to return funds to a specific OWCP program must complete the following:

- DEEOIC: The program does not accept payments made by mail. All providers must submit an adjustment (corrected bill) to ensure that the overpayment created is properly reflected as an account receivable by DEEOIC. Once the account receivable is established, providers will receive a debt letter and instructions on how to service the account receivable from the Treasury's Centralized Receivables Service (CRS). Refer to the section <u>"How to Submit Refunds of Overpayments"</u> of the How to Guides for Medical Providers page.
- DCMWC: Outstanding debts are automatically recouped by the program. Any outstanding account receivable (AR) balance is automatically recouped from future payments until the AR balance reaches \$0.00. Effective August 24, 2024, if the debt remains unpaid after 120 days from the Remittance Voucher (RV) overpayment notice, the account balance will be sent to the Centralized Receivables Service (CRS) for collections.

### 6.5.2 OWCP Fee Schedule

The OWCP fee schedule sets maximum fees payable for medical services, supplies, and devices provided to claimants. Payment for medical and other health services, devices, and supplies furnished by physicians, hospitals, and other providers for work-related injuries or illness shall not exceed the maximum allowable fees outlined in OWCP fee schedule.

### 6.5.3 Fee Schedule Appeal

If OWCP reduces a fee, the provider may request a reconsideration of the reduction. The provider can submit an appeal when the provider whose charge for service is partially paid because it exceeds the maximum allowable amount. The appeal request must be within 30 days of payment.

All appeal requests must be accompanied by documentary evidence that:

(1) the actual procedure performed was incorrectly identified by the original code, or

(2) the presence of a severe or concomitant medical condition made treatment especially difficult, or

(3) the provider possessed unusual qualifications (board certification in a specialty is not sufficient evidence of unusual qualifications).

## 6.6 Eligibility

Providers registered on the WCMBP self-service portal can easily view the approved diagnoses for the injured or ill worker. The self-service feature informs providers whether an authorization is required to treat the injured or ill worker.

Checking a claimant's eligibility prior to submitting a bill or authorization request helps prevent denials as this function alerts the provider if a procedure code requires authorization or if a claimant is eligible for the type of service being billed.

Providers need only enter the following information:

- Appropriate OWCP program (DFEC, DEEOIC, or DCMWC),
- Claimant case ID,
- At least one diagnosis code,
- A procedure code or revenue code and required procedure, and
- Date of service.

Once all the above information is added, select **Submit** to view the results of the eligibility inquiry. The result will indicate:

- Whether the service requires authorization
- Whether the diagnosis entered is related to the claimant's accepted conditions
- If the result returns an error "Requested Diagnosis Service is not related to the claimant's accepted conditions", refer to <u>Services for Accepted Conditions</u> for resolving this error message.



Providers have access to the Electronic Case Lookup feature to enter claimant information to obtain a claimant's OWCP case number.

## 6.7 Remittance Voucher and Tax Form – 1099

Providers can obtain payment correspondence using the WCMBP self-service portal.

### 6.7.1 Remittance Voucher

The Remittance Voucher (RV) is a detailed payment correspondence generated from the WCMBP System that is mailed to providers. The RV provides information on bill transactions processed and the disposition of those transactions. The RV provides the amount being paid and denied to the providers and the underlying basis for the payment or denied amount, as well as any overpayments owed to the DOL program. Each transaction correlates with a respective bill status, explanation of benefit (EOB), and reason code.

The RV includes summary and detailed information regarding withholdings and recoupments, if applicable. RVs are mailed weekly to providers. Providers have the option to "go paperless" and elect to receive outbound OWCP medical bill processing correspondence electronically only through the WCMBP Portal, including Remittance Vouchers (RVs). For instructions on how to opt for paperless correspondence, refer to the <u>Updating Provider Information in the Provider</u> <u>Portal reference guide.</u>

### 6.7.2 Tax Form – 1099

The DOL issues a single 1099-Misc form for every Tax ID with payment totaling \$600 or greater for the tax year. The printed tax forms are mailed to the provider identified as the "Legal Entity" within the WCMBP System.

All Medical reimbursements are reported in Box 6 of the 1099-Misc form, while Backup withholdings are reported in Box 4 of the 1099-Misc form. The 1099-Misc forms are also available for download from the WCMBP self-service portal under the EXT-Provider File Maintenance profile.

#### **Backup Withholding:**

Backup withholding is a tool used by the IRS to ensure that taxes are paid on certain types of income that were not reported correctly. Providers can be subject to backup withholding if their tax ID and business name provided to OWCP does not match what the IRS has on file.



Payments that are backup withheld are reported in Box 4 of the 1099-Misc form for the respective tax year. The backup withheld amounts are also reported on the weekly Remittance Voucher.

OWCP will backup withhold 24% of provider payments as instructed by the IRS in accordance with IRS Publication 1281. To view the publication, go to <u>IRS Publication 1281</u>.

The IRS Publication 1281 also includes steps to address the first notification and second notification of an incorrect name and tax ID combination. Providers may submit a Form W-9 to address a First "B" Notice letter. Providers must submit an IRS Letter 147C to address a Second "B" Notice letter. Documentation may be submitted through the online WCMBP Portal, by fax, or by mail.

## 7 CALL CENTER

The Office of Workers' Compensation Programs (OWCP) is contracted with Acentra Health to manage the call center operations for the Workers' Compensation Medical Bill Processing (WCMBP) program for the Federal Department of Labor (DOL). Acentra Health maintains a centralized call center with dedicated call agents who are experienced and ready to assist providers with eligibility, authorization, payment, and enrollment inquiries for all three major disability compensation programs. The call center hours of operation are 8 AM to 8 PM Monday through Friday (Eastern Time) where providers can speak with a live agent. There is a separate toll-free number for each OWCP program.

In addition to the call center, providers have access to the 24-hour Interactive Voice Response (IVR) system. Providers can choose to use the IVR to obtain information on eligibility, authorization, payment, and enrollment inquiries. The IVR provides the same detailed, up-to-date information that is available to the call center agents. The IVR is available 24 hours a day, seven days a week, every day of the year (except during times of scheduled maintenance).

## 7.1 Medical Treatment Adjudicators

The Medical Treatment Adjudicators (MTA) services are available to **DFEC providers only**. To reach an MTA, DFEC providers must call the Acentra Health call center at 1-844-493-1966 for assistance. If a call center agent is unable to respond to the provider's question, the call center agent transfers the call to a DFEC MTA. After entering the case number through a phone prompt, the caller is transferred directly to the MTA assigned to the case.

Calls may be transferred for the following issues:

- Authorization:
  - Authorization denials with no denial reason indicated in the WCMBP System.
  - Level 3 authorization pending for more than 45 days with no resolution.
  - Unexplained reason for the CE reducing units or dollar amounts submitted on an authorization.
- Billing:
  - Denied bills for non-covered services.
  - Providers needing to speak with the claimant's CE on case file updates and status.
- Documentation: Previously submitted correspondence for the claimant case file not addressed by the claimant's CE.



## 8 PROVIDER OUTREACH

OWCP and Acentra Health conduct various forms of provider outreach to ensure providers receive the information and support needed to navigate the Workers' Compensation Medical Bill Processing (WCMBP) System. The goals of our outreach efforts are to: (1) assist providers with challenges they experience in the enrollment, authorization, and billing processes, and (2) gain feedback from providers to help improve OWCP's processes to make it easier for providers to work with OWCP. Below are a few of our current outreach efforts.

#### **Focus Group Sessions:**

OWCP and Acentra Health occasionally host Focus Groups, which are small open-forum conversations for provider participants to share their thoughts and recommendations as part of their experiences interacting with the WCMBP System. Providers can check the WCMBP self-service portal for a banner message on upcoming Focus Group sessions.

#### Virtual Help Sessions:

OWCP and Acentra Health host virtual help sessions on the first Friday of each month where providers have an opportunity to ask general questions regarding the medical bill processing system including enrollment, authorization submission, billing, and web portal features. Refer to the <u>Upcoming Webinars</u> page for information on upcoming virtual help sessions.

#### **New Provider Orientation:**

OWCP and Acentra Health host new provider orientation sessions on the third Wednesday of each month where newly enrolled OWCP providers have an opportunity to join the webinar for an overview of the medical bill processing system including eligibility inquiry, authorization submission, billing, enrollment updates, and user administration. Refer to the <u>Upcoming</u> <u>Webinars</u> page for information on upcoming new provider orientation sessions.

#### **Portal Refresher Sessions:**

OWCP and Acentra Health host quarterly portal refresher sessions where providers have an opportunity to view a step-by-step walkthrough of the portal related to a specific topic, such as billing or provider file maintenance. Refer to the <u>Upcoming Webinars</u> page for information on upcoming virtual help sessions.

#### The Provider's Corner:

Another outreach opportunity is The Provider's Corner and Tips page on the WCMBP selfservice portal. This page is a source of tips, helpful hints, and additional information regarding existing processes and common questions.
